

MBBS Degree recognized by MCI from a recognized university with minimum of **10 years'** R&D experience in Genetics or biomedical subjects OR

Ph.D. degree in life sciences/ Biochemistry/ Microbiology/ Biotechnology in the relevant subject or equivalent from a recognized University with **5 years** R&D experience in the related subject after Ph.D.

OR

First class Master's Degree in Biochemistry/ Microbiology/ Biotechnology /equivalent degree from a recognized University with **8 years** R&D experience in Genetics or the biomedical subjects in recognized institute(s)
